**Loan No. 2528-IND: North Eastern Region Capital Cities Development Investment  
Program – Project 1 – Amendment to the Loan Agreement**

Dear Dr. Pujari:

1. This refers to the Loan Agreement for the captioned Project signed on 4 August 2009. The capitalized terms used and not defined herein have the same meanings as defined in the Loan Agreement. The total loan amount under the Loan Agreement is \$30,000,000 as shown in Section 2.01 (a) and in the Table on Allocation and Withdrawal of Loan Proceeds (Attachment to Schedule 3). However, the figures in Section 3.01 (b) add up to \$30,000,200.
2. We propose to reduce by \$200 the total amount for Nagaland which has the highest allocation among the States. We also propose to show the distribution of the Unallocated amount in the Table on Allocation and Withdrawal of Loan Proceeds among the States and the Ministry of Urban Development (MOUD).
3. Accordingly, please find below the revised Section 3.01 (b) and the Table on Allocation and Withdrawal of Loan Proceeds.

The existing sub-section (b) of Section 3.01 is hereby deleted and consequently revised as follows:

- (b) Of the Loan proceeds, the Borrower shall provide (i) to MOUD an amount equivalent to four hundred ninety one thousand and nine hundred dollars (\$491,900); (ii) to Meghalaya an amount equivalent to four million six hundred twenty two thousand and five hundred dollars (\$4,622,500); (iii) to Mizoram an amount equivalent to five million three hundred forty nine thousand and five hundred dollars (\$5,349,500); (iv) to Nagaland an amount equivalent to seven million seventy thousand and three hundred dollars (\$7,070,300); (v) to Sikkim an amount equivalent to six million nine hundred sixty five thousand and four hundred dollars (\$6,965,400); and (vi) to Tripura an amount equivalent to five million five hundred thousand and four hundred dollars (\$5,500,400). MOUD and the States shall apply the proceeds of the Loan in accordance with the allocation of Loan proceeds under Schedule 3 to this Loan Agreement.

The existing Table on Allocation and Withdrawal of Loan Proceeds is hereby deleted and consequently revised as follows:


