

KA UPDATED INITIAL ENVIRONMENTAL EXAMINATION NA KA BYNTA KA TRANCHE 2 NERCCDIP

Jingbatai Lyngkot ia ka projek (Executive Summary)

1. Ia ka North-Eastern Region Capital Cities Development Investment Program (NERCCDIP) la pyntrei da ka jingthmu ban pynurlong ia ka bit ka biang ha ka jingroi jong ki nongbah ka thain shatei lam mihngi kum ka Agartala, Aizawl, Gangtok, Kohima, bad Shillong lyngba ka jingbei pisa ha ki tnad kam pynroi sor bapher bapher. La sdang ban pyntreikam ia ka NERCCDIP naduh ka snem 2010 bad ka jingpyntreikam kan neh palat 6 snem bad la bei pisa da ka loan lyngba ka Multitranche Financing Facility (MFF) jong ka Asian Development Bank (ADB).
2. Ka Ministry of Urban Development (MOUD) kan dei ka tnad pyntreikam na ka liang jong ka sorkar pdeng. Ki State-level Investment Program Management and Implementation Units (SIPMIU) ha manla ki jylla kin pyniaid bad pyntreikam ia baroh ki kam (subproject) bala bei pisa da kane ka Investment Program. Ia ka SIPMIU yn iarap da ka Design, Management and Supervision Consultants (DMSC) ha kaban pynwandur (design), iarap pyniaid bad khmih bniah ia baroh kine ki jingtrei.
3. Ha baroh ki kam ba ka pyntrei ka ADB, ka donkam ia ka jingkhmih bniah ha baroh ki phang ba iadei bad ka mariang. Ia ki rukom bad jingdonkam ha kaba iadei bad ka jingkhmih bniah ia ka mariang (Environmental Assessment) la batai shai ha ka ADB's Safeguards Policy Statement (SPS, 2009).
4. Ha ka Tranche 1, la pyntreikam ia ka emergency landfill ha ka jaka baheh 6,500 square meters (phase 1) ha Marten ryngkat bad ka jingthied ia kawei ka bulldozer. Ha ka Tranche 2 la pyntrei ia kine ki kam harum:- (i) ka jingtei ia ka garage cum workshop shed bad ka staff restroom ha Marten; (ii) ka jingthied bad sam ia ki borti lum niut kiba pher ba pher bad ki tiar jingiada ia ki nongtrei; bad (iii) ka jingthied ia ki kali kit niut bad ki tiar karkhana. Ia ka jingtreikam ban tei ia ka emergency landfill la sdang ha u March 2012 bad la khmih lynti ban dep ha u October 2015. Ka jingtei ia ka garage cum workshop la sdang ha u April 2013 bad la thmu ban pyndep ha u June 2015.; ka jingthied ia ki kali kit niut bad kiwei kiwei ki tiar ka la sdang ha u June 2012; ka jingthied bad jingsam ia ki bin bad ki tiar ai jingiada la sdang ha u July 2014 bad la thmu ban pyndep ha u June 2015.
5. Ia kane ka Updated Initial Environmental Examination la pynkhreh na ka bynta kine ki kam kiba harum kiba dang shu kynthup shen ha ka Tranche 2 : (i) Ka jingshna ia ka emergency sanitary landfill ka ba heh kumba 8,500 m² (phase 2) ha Marten, kane ka kam

ka kynthup ia ka jingtei kynroh reinforced cement concrete (RCC), ka leachate holding bad treatment system, ka guard bad weighbridge operator building, ka jingker pud da ki sainar shiah, weigh bridge, bad kumta ter ter, (ii) ban thied ia ki tiar (machine) ba kynthup ia ka tracked excavator, vibratory tandem roller, skid steer loader, tanker um, ki tiar ban iakhun ia ka jingklang ding, hydraulic baling press, machine sar surok, bad ka open nallah desilting machine.

6. Ia kane ka kam yn pyntrei ha Marten, ka jaka kaba jngai kumba 8 km napdeng sor Shillong. Ym don jaka sah biew, jaka adong, jaka langum lane ki jaka ri jingri ha kane ka jaka ba thmu ban pyntreikam.

7. La peit thuh lypa ia kino kino ki bynta kiba lah ban shah ktah na ka jingpyntreikam ia kine ki jingtrei bad la i ba kannym don jingktah satia na ka liang ka design lane na ka jaka. Ka Environmental Management Plan (EMP) kan dei ka bynta jong kane ka IEE kiban kynthup ia: (i) ki lad ai jingiada ia ka mariang ha ka por ba pyntreikam, (ii) ki lad khmih bniah ia ka sawdong sawkun (environmental monitoring program), bad ki tnad treikam ban peit iaka bha ka miat ka mariang; (iii) ka iamir jingmutlang bad ka jing ai jingtip sha ki paidbah; bad (iv) ki lad ban peit ia ki jingujor (Grievance Redress Mechanism). La la pynkhreh lypa katba lah ei ia ki lad jingiada ban pynduna ia ka jingktah ia ka mariang.

8. Ha ka por ba shna, ka jingktah kaba kham paw kan dei ka jingpum pum bal ah ban mih na ka jingtih khyndew bad ka jingsawa ki machine.

9. Ka don ka jingthmu ia ka jingthung dieng sawdong pud. Ka project kan pyrshang ban ai kam ia ki biew basah hajan kane ka jaka ban iarap ia ki ban kamai jakpoh.

10. Yn pynthikna ban ai ia ki lad jingiada lyngba ka jingkhmih bniah (environmental monitoring) ha ka por ba pyntreikam ia kane ka project kumba la thmu. Kane kan kynthup ia ki jingkhmih bniah hapoh bad ha ki jaka markhap jong ka jaka treikam, da kaba peit ia ki kot ki sla bad kylli na ki biew kiba trei bad iadei kam. Lada don kano kano ka kam ban pynbha, lah ban ai jingtip ia ka SIPMIU, Shillong.

11. Ki nongdon bynta ban pynkhreh ia ka IEE ka long lyngba ka jingiakynduh mar khmat ha jaka pyntrei ia kane ka project bad ha ki jingialang ba pynlong ha ka nongbah ha kaba baroh ki jingai buit, ban pynbha bad pynurlong ia kane ka project la pynrung lang ha ka IEE. Ia ka IEE yn lah ban iohi paidbah na ka website jong ka office bad na ka website jongka ADB. Ia kane ka jingiamir jingmut yn dang iai bteng katba nang iaid ka kam ban pynthikna ba baroh kin iadon bynta lang bad ka projek bad ba kin ioh ia ka lad ha kaba pynbha ia ka rukom treikam.

12. Ym iohi ba kane ka jingtrei kan don ka jingktah kaba sniew ia ka mariang sawdong. Kino kino ki jing ktah ba sniew, balah ban mih na kane ka jingtrei, la pynduna da kaba pynbit pynbiang bha ia ki engineering design bad kiwei de ki lad jingiada. Na ka jingshem na ka IEE, lah pynhap ia kane ka projek ha ka category B bad ym donkam shuh ban leh ia kano kano ka jingwad bniah katkum ka ADB SPS (2009) lane ka GoI EIA Notification (2006).
