Request for Proposal

For Implementation of the Project – Municipal Solid Waste to Energy (WTE) facility in Shillong.

The Shillong Municipal Board and the Urban Affairs Department, Government of Meghalaya proposes to enter into a DESIGN-BUILD-FINANCE-OPERATE-TRANSFER contract with an identified Private Sector Provider to implement the “Project” - Municipal Solid Waste to Energy (WTE) facility in Shillong. The period of the concession will be of 30 years. The Shillong Municipal Board hereby invite Proposals from the interested Parties as per the laid out norms in Request for Proposal (RFP).

The RFP document can be obtained from the office of the CEO, SMB, Shillong from 19<sup>th</sup> April 2012 to 4<sup>th</sup> May 2012 between 1100 Hours and 1500 Hours IST on all working days at the address given below on payment of a non-refundable amount of Rs. 10,000/- (Rupees Ten Thousand only) towards processing fees through a Demand Draft drawn from any Nationalized/scheduled/an Indian Branch of Foreign Bank in favour of ‘**Chief Executive Officer, Shillong Municipal Board**’ and payable at Shillong. The RFP will also be available for download free of cost from Shillong Municipal Board’s website <http://smb.gov.in/> and Govt. of Meghalaya’s website <http://meghalaya.nic.in/> between 19<sup>th</sup> April 2012 and 4<sup>th</sup> May 2012. Those downloading the document must submit the amount of Indian Rupees (INR) 10,000/- (Indian Rupees Ten thousand only) along with the bid document. Those downloading the document from the website must notify in writing to the Shillong Municipal Board about their intent to participate.

Prospective Bidders are advised to read the 3 (three) volumes in conjunction and are advised to comply with the terms & conditions for submission of their Proposal as defined in this RFP document. The Private Service Provider would be selected through an Competitive Bidding Process. A “Single-Stage” process would be followed for determining the Preferred Bidder i.e. there will not be any separate pre-qualification stage for short listing of bidders. Selection of successful Bidder would be through evaluation of the Proposals which are to be submitted by prospective Bidders as specified in the RFP document.
