As a minimum the Bidder must show that his resources, in terms of at least his latest year's working capital and lines of credit,

will be adequate to cover his Bid Price and current work commitments. The working Capital of the firm should be 12.50 Millions

Working Capital = Current Assets – Current Liability + Dedicated Line of Credit
